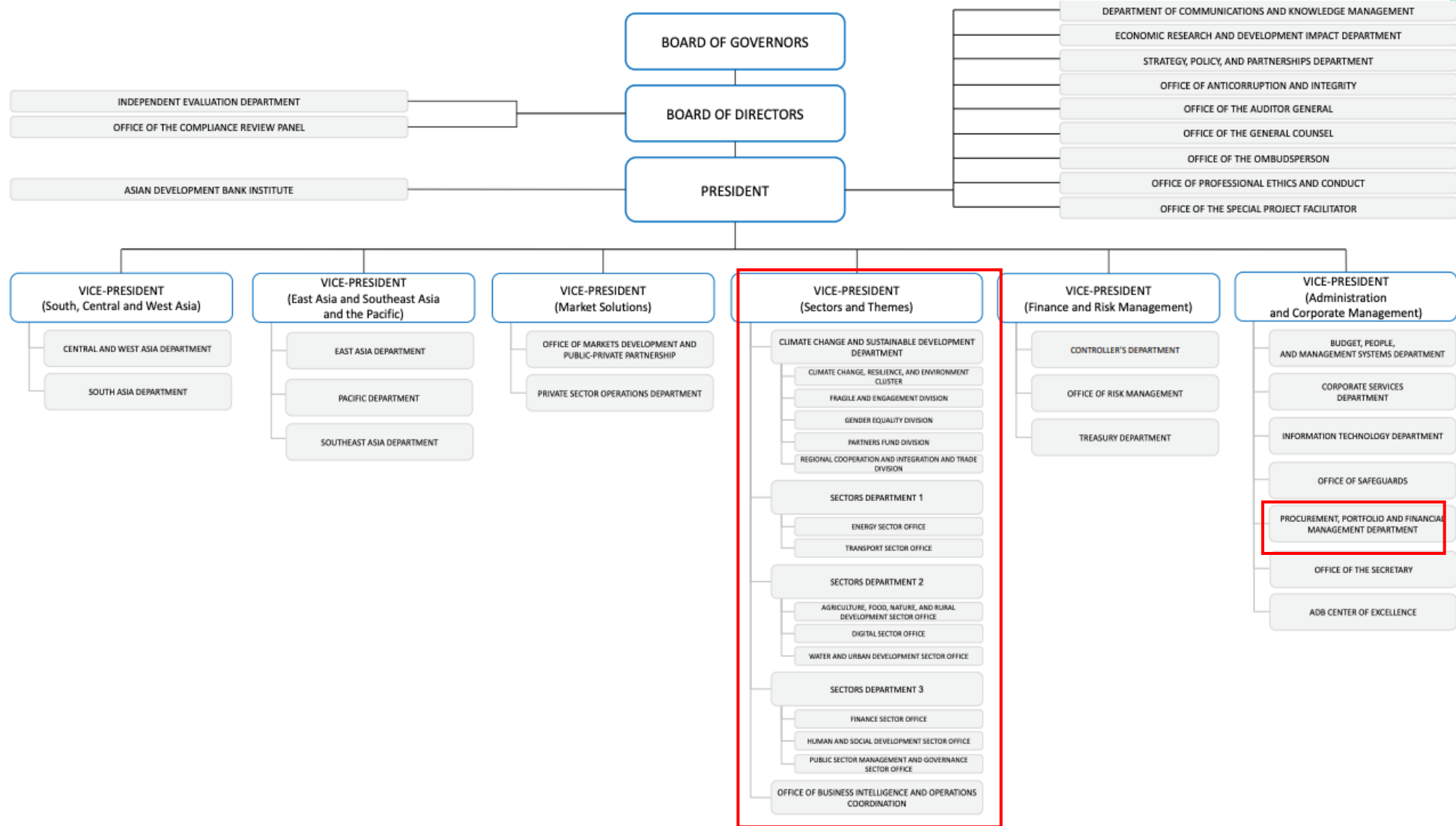

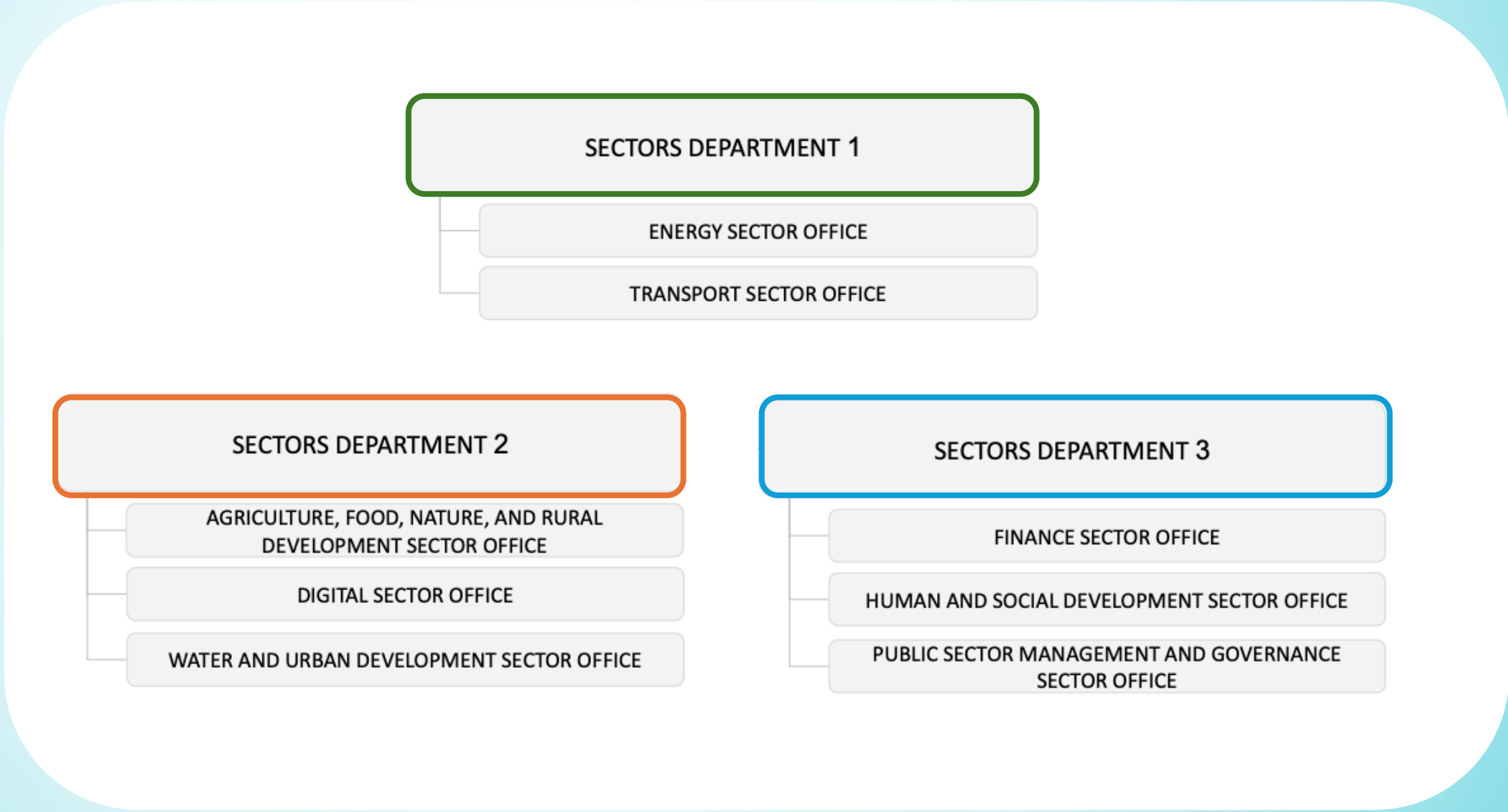


ADB FUNCTIONAL ORGANIZATION

WHY DOING BUSINESS WITH ADB?

There are two distinct types of procurement where ADB is involved:

1. Procurement under its technical assistance projects where ADB procures and signs contracts; and
2. Borrower administered procurement where the government procures and signs contracts.

Technical Assistance

(ADB Administered)

Provided to governments, but contracts are procured and managed by ADB

Mostly consulting services (feasibility studies, due diligence, knowledge work)

Contracts signed by ADB, subject to English law

Consultants have some privileges & immunities when in project country

Loans and Grants

(Borrower Administered)

Provided to and managed by Governments

Procurement of Works, Goods and Services

Government does procurement (ADB oversight)

Contracts signed by Government, subject to local laws

WHY DOING BUSINESS WITH ADB?

Roles of ADB, Borrower, Suppliers when the government is procuring:

- Responsible for project implementation.
- Accountable for carrying out all procurement activities per ADB rules.
- Contracting with all contractors, suppliers & consultants.

Borrower



- Assist borrowers in designing projects.
- Ensuring funds are used for the purpose intended through monitoring and oversight activities
- Provide implementation support, where needed.

ADB



- Express interest in working with borrowers.
- Comply with requirements in bidding documents and contracts with Borrowers.
- Deliver the infrastructure that changes lives across the region

NOTE: The 2026 reforms are primarily focused on contracts subject to international advertisement but can be applied across ADB's entire portfolio of projects.

Enhance Competition



- Early market engagement with suppliers before bidding
- Market-facing contract terms & conditions
- Transparency promoted through beneficial ownership declarations

Improve Quality



- Use of quality-focused evaluation methods (merit-point criteria – MPC) on large contracts
- Enhance borrower capacity to procure effectively
- Promote collaborative forms of contracting

Promote Sustainability




- Support local job creation through procurement

- Incorporating O+M considerations



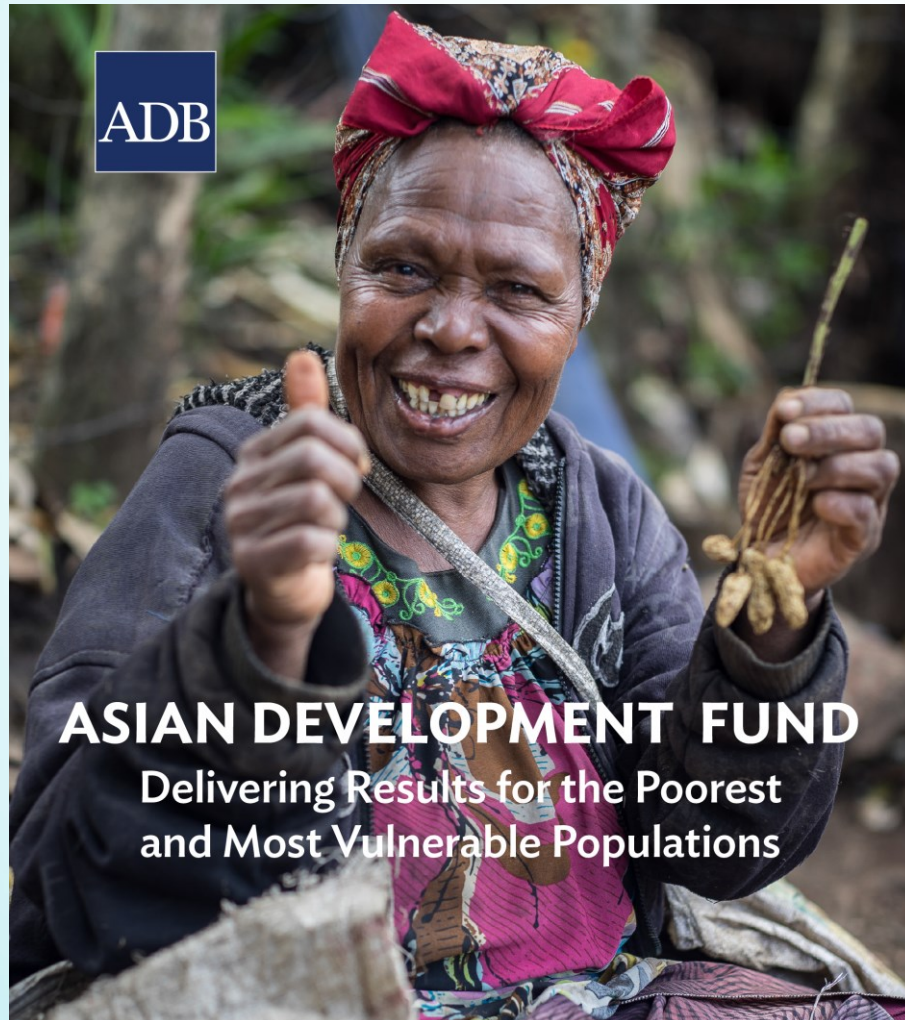
