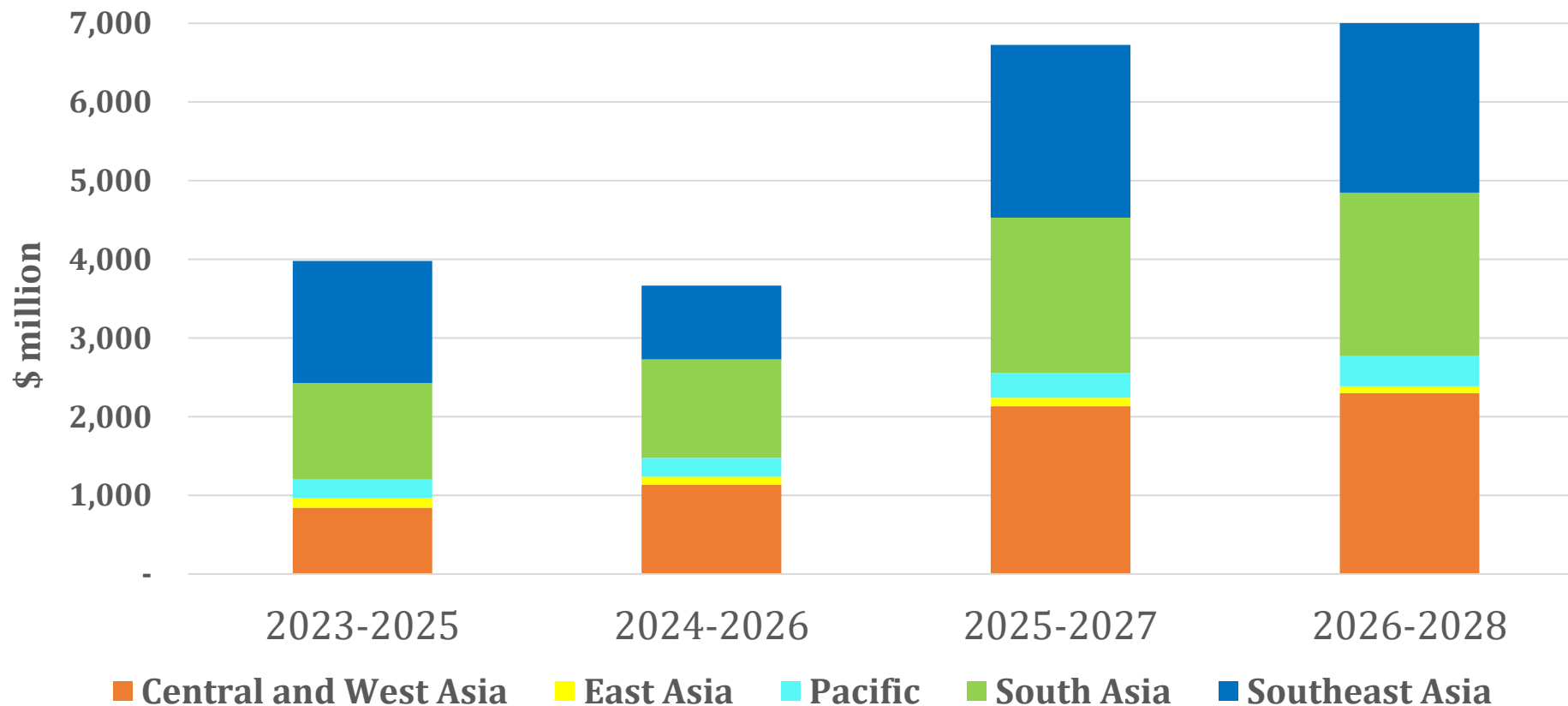

Loans and Grants (2023 to 2028): 3-Year Moving Average

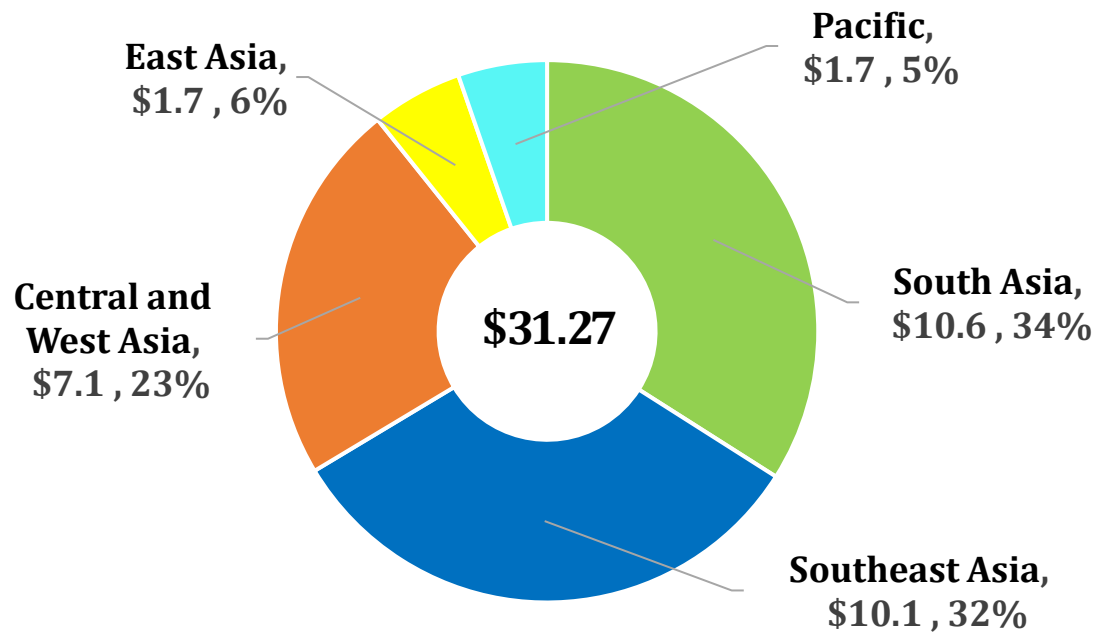

Active Loans/Grants, and TAs by Region (as of Feb 2026)

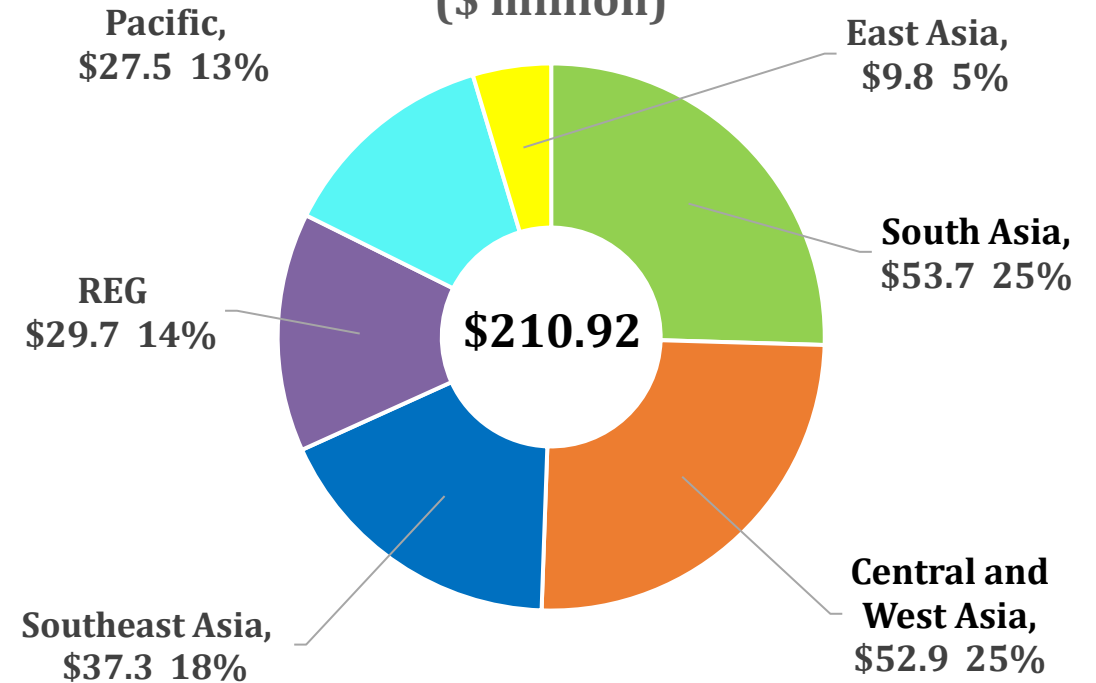
Active Loans/Grants by Region

(\$ million)



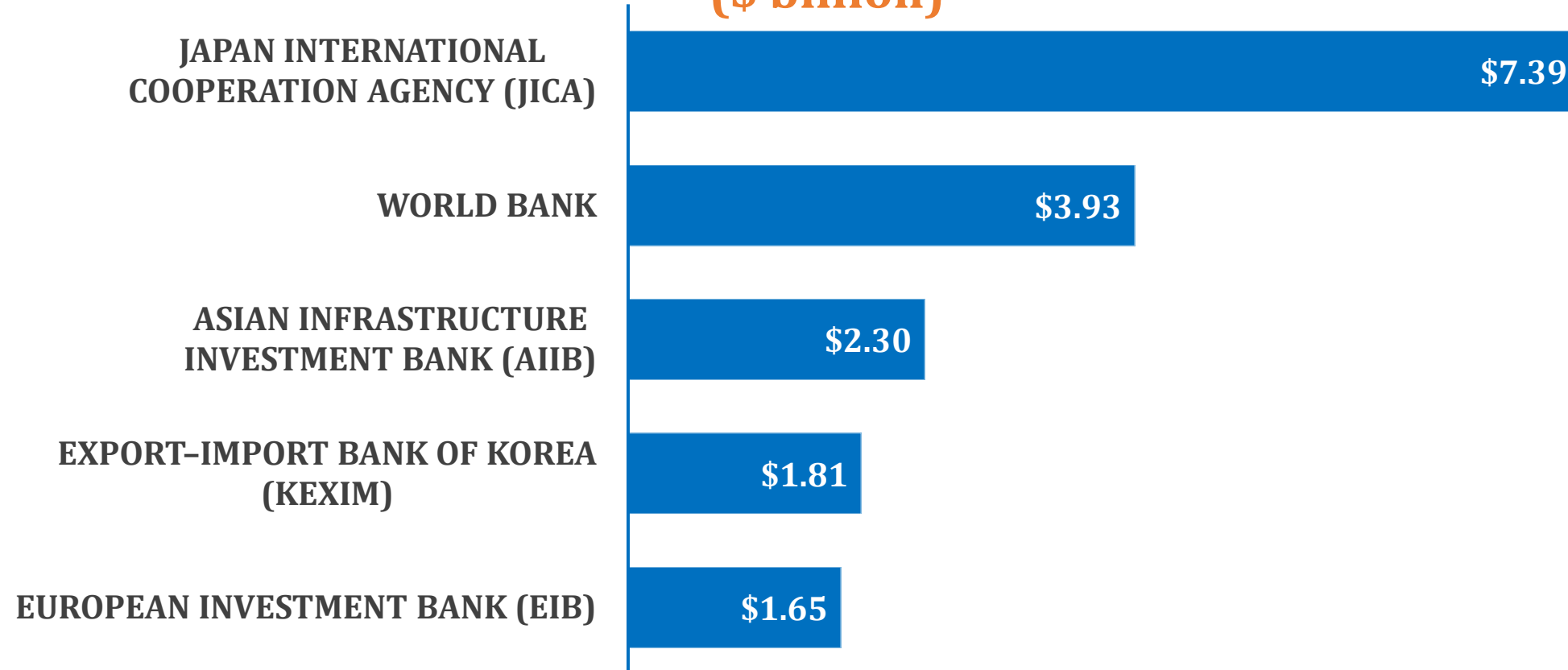

Cofinancing with Partner Organizations

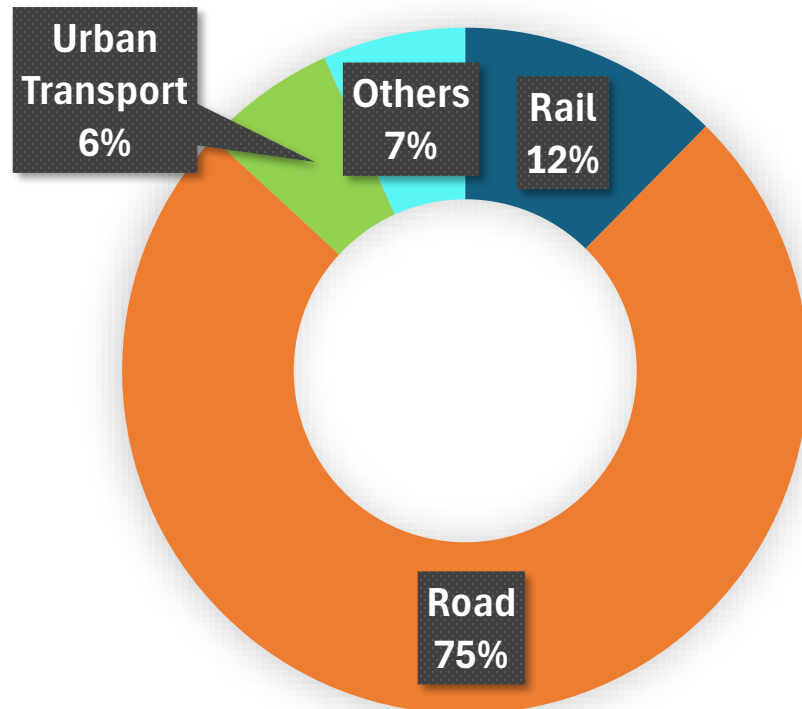
Top Cofinancing Partners, 1970 to date
(\$ billion)



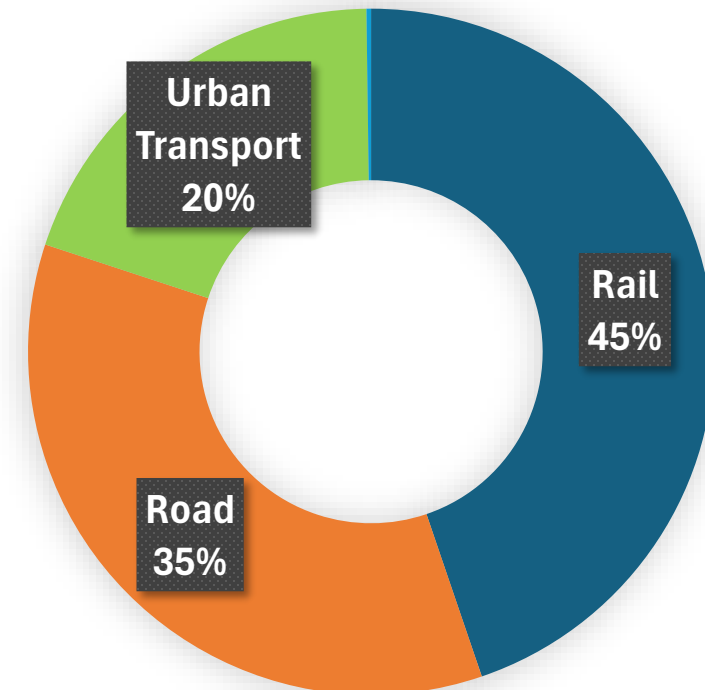


Subsector shift over years

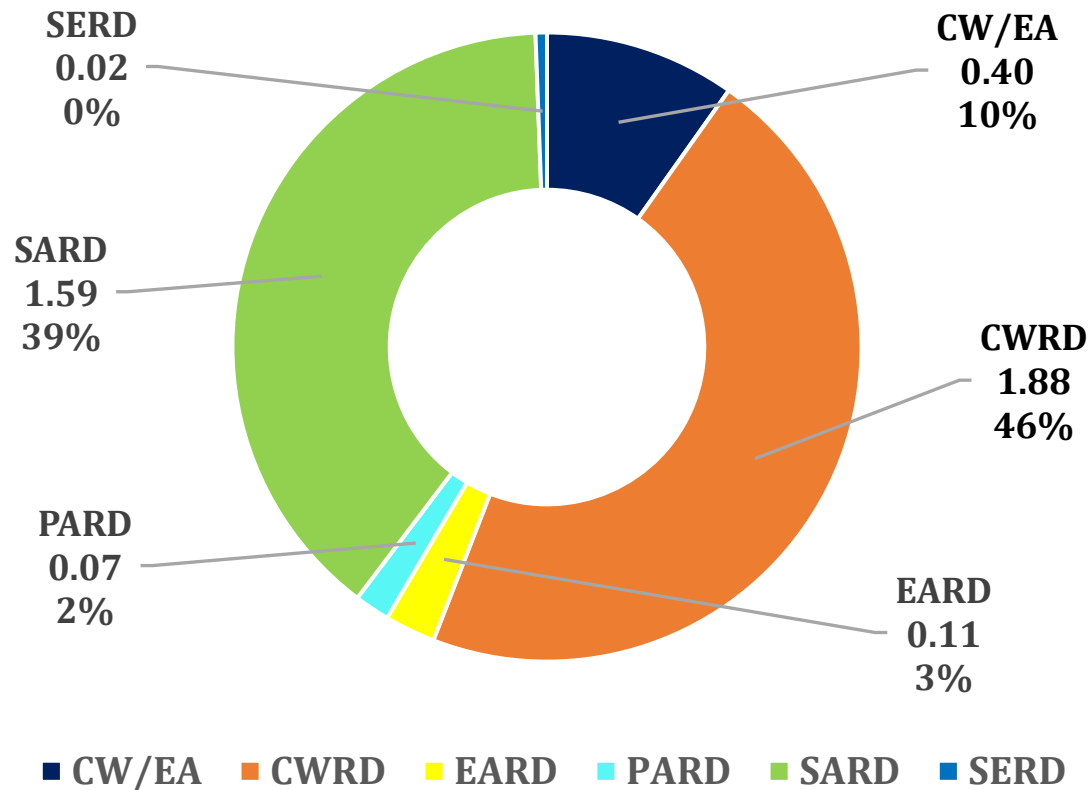

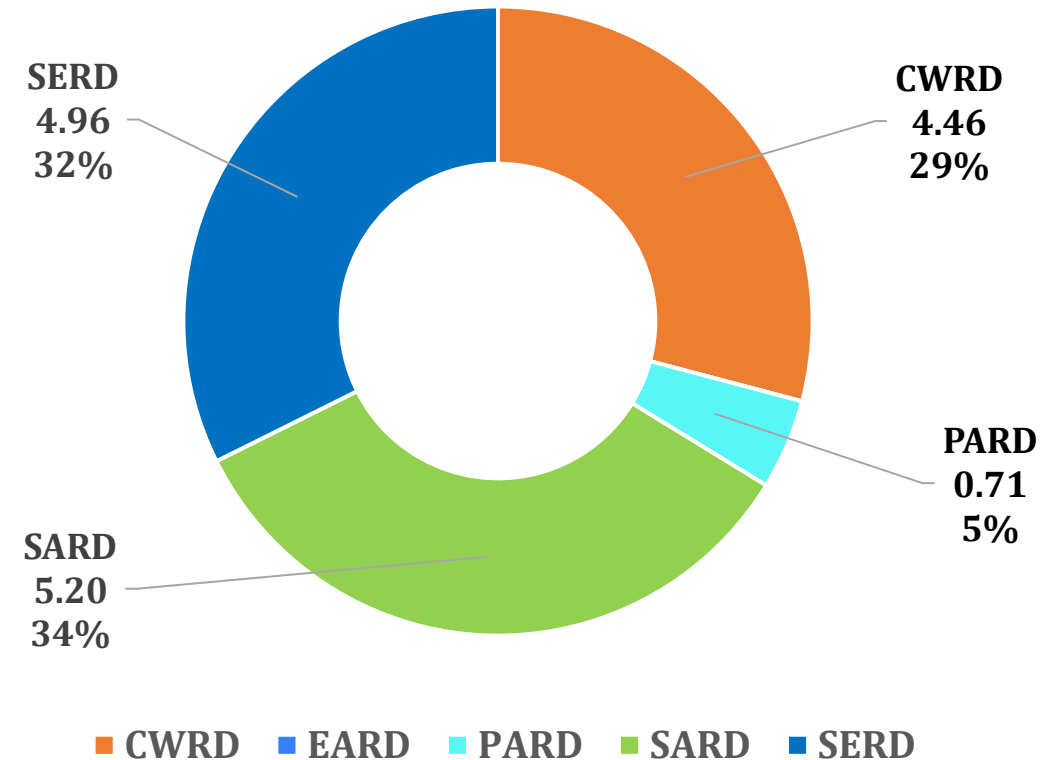


Pipeline projects by region

2026 Projects by Region (\$ billion)



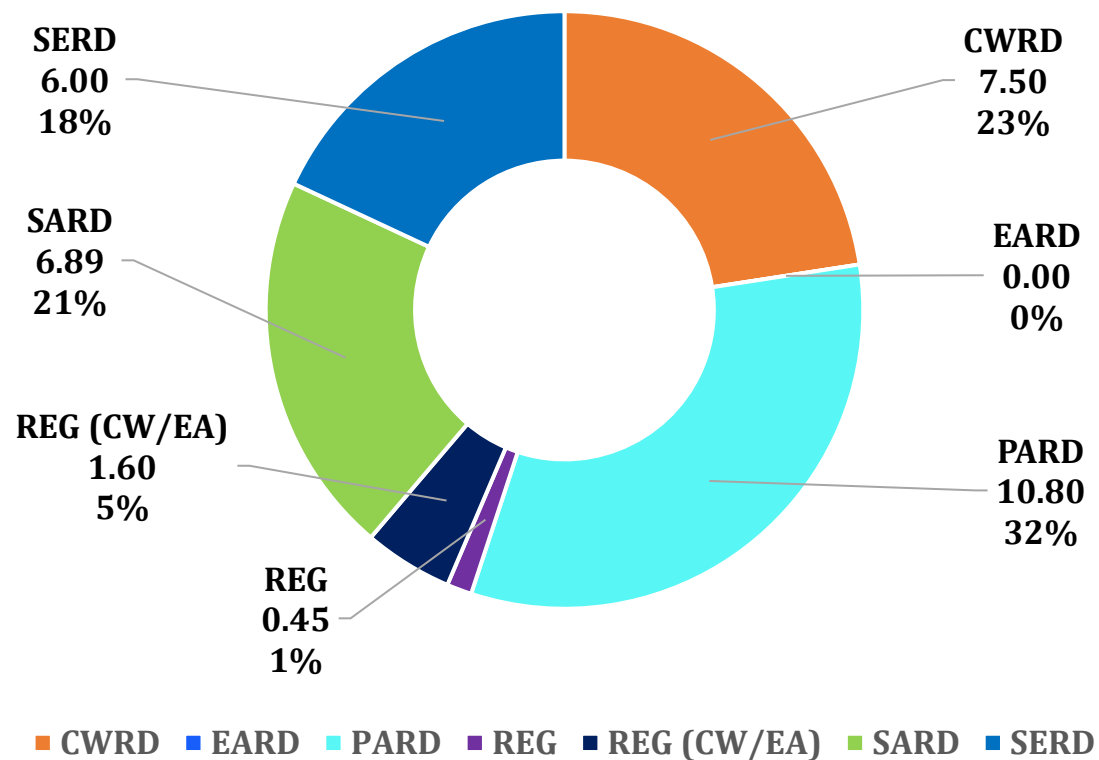
2027 Projects by Region (\$ billion)



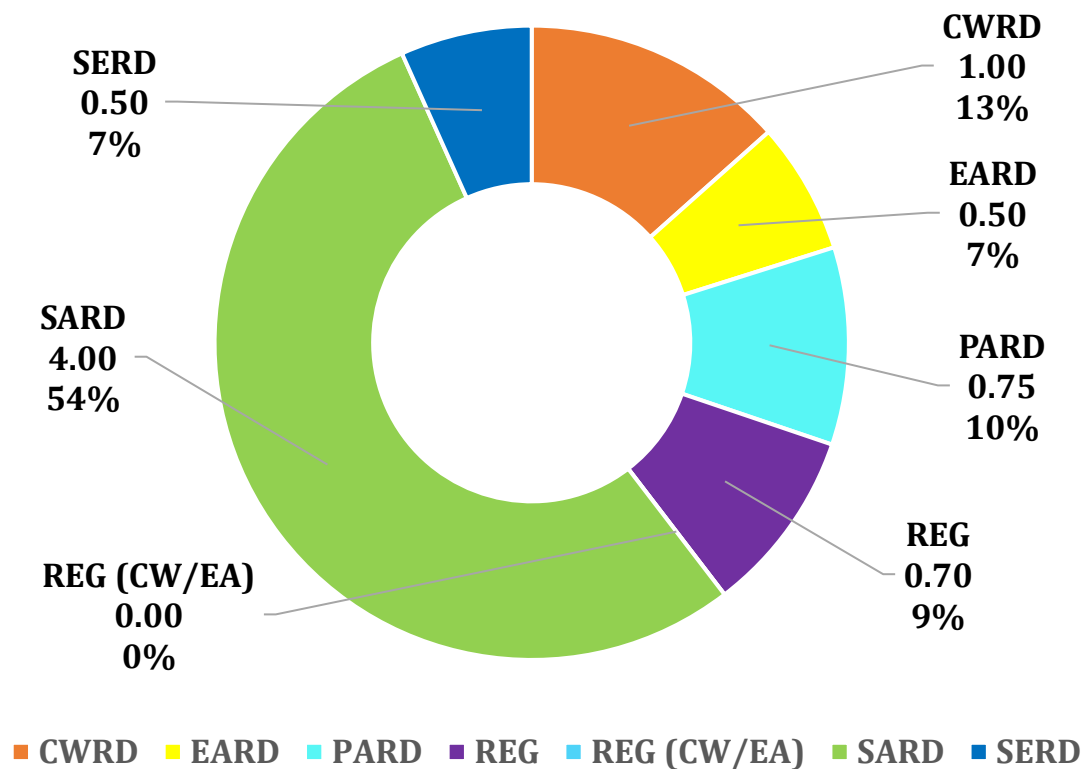


Technical assistances by region

AZE: Railways Digital Transformation Project (2025)

Total Amount: \$47 million

ADB: \$47 million

Approval: September 2024

Commitment: January 2025

Project Description:

Digitalization of key processes at the Azerbaijan Railways (ADY) Closed Joint Stock Company (cargo operation management, assets, investment and construction, cargo commercial system, and corporate functions)

Improvement of ADY's operational and financial performance through streamlined data management, optimized asset management and overall rail operations, reduced cost, enhanced rail safety, and better workforce efficiency.



PHI: North–South Commuter Railway (NSCR) O&M Concession (2025)

Client: Department of Transportation

Estimated Project Size:

- Build cost: \$15 billion; O&M cost: \$3 billion

Project Description:

The project is a 147-km rail line, cofinanced by ADB and JICA, cutting travel time between Metro Manila and Clark to under 1 hour. The Project will provide advice on legal requirements, risk allocation, and structuring the O&M contract. It will also assist in tender process, preparing concession agreements and additional support for capacity building.

The O&M Concession involves sovereign-funded construction and private sector-managed operations and maintenance through a long-term concession agreement. The tender for the North-South Commuter Railway's O&M concessionaire will involve availability payments tied to performance.



NEP: Sustainable Urban E-mobility Project (2025)

Total Amount: \$160 million

- **ADB: \$100 million**
- **Cofinancing: \$40 million (GCF)**
- **Counterpart: \$ 20 million**

Approval: November 2025

Commitment: December 2025

Project Description:

The project will deploy new electric buses and modernize traffic infrastructure with ITS (Kathmandu Valley).

Improve public transit infrastructure, promote green and livable city concepts, and bolster the city's tourism potential (Pokhara Valley).

This project will foster institutional capacity and green transportation skills, positioning both valleys at the forefront of sustainable urban mobility.



FIJ: Critical Bridges Resilience Project (2024)

Total Amount: \$199.5 million

- **ADB: \$134.5 million**
- **Cofinancing: \$50.0 million (WB)**
- **Counterpart: \$15.0 million**

Approval: November 2024

Commitment: December 2024

Project Description:

Improvement of Fiji's rural and urban transport connectivity

Replacement of key bridges essential to domestic transport network.

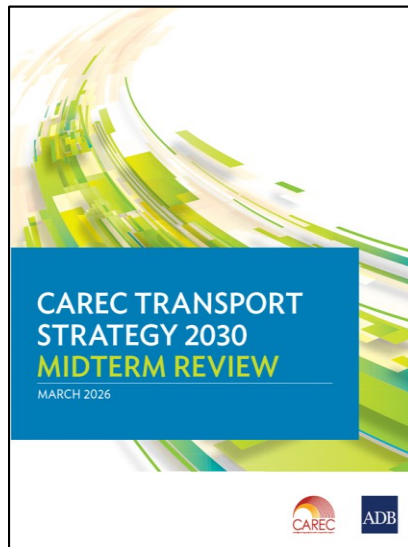
Address the operations and maintenance capacity issues of the Fiji Road Authority on inspecting and maintaining the bridges.



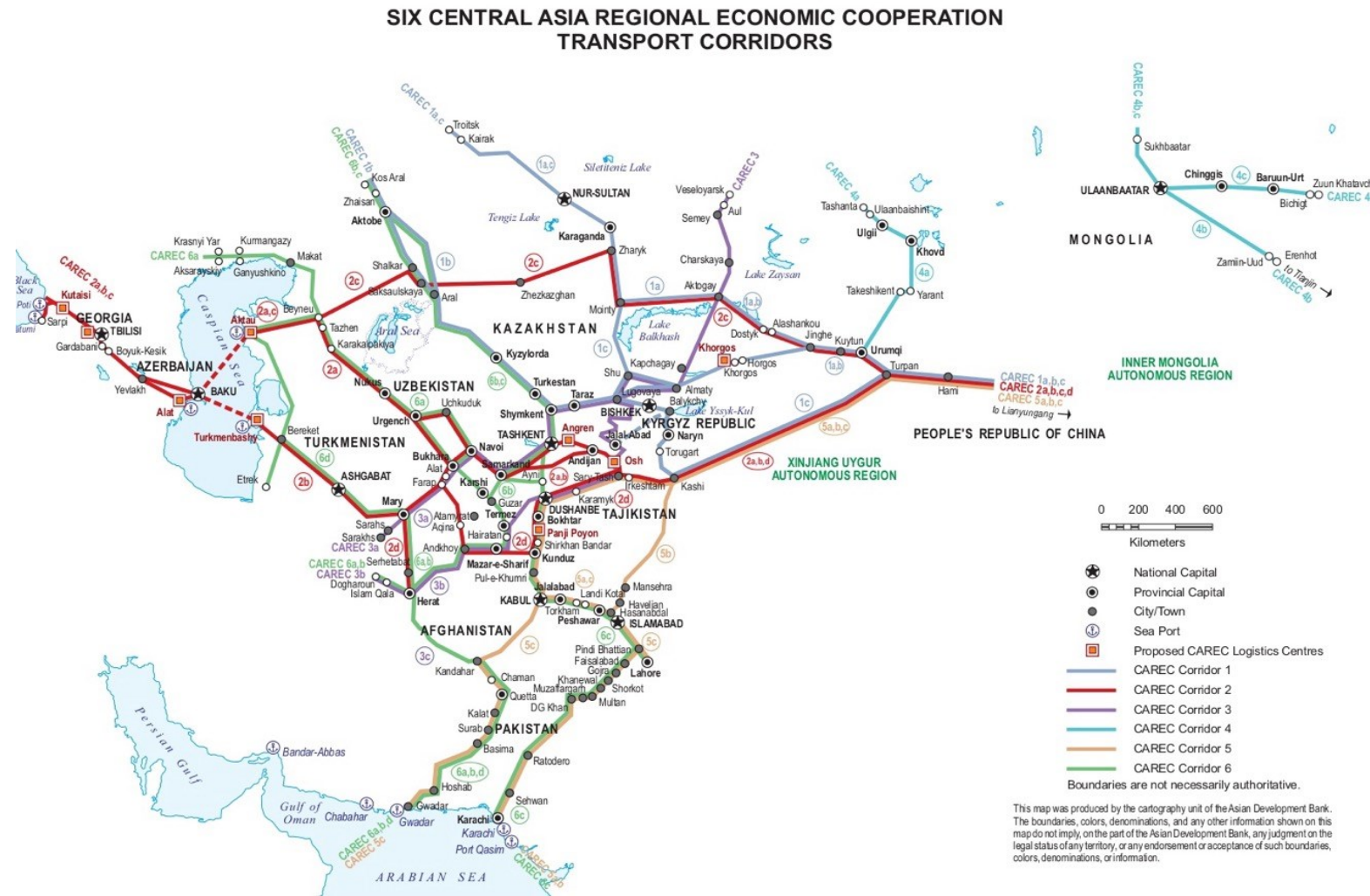


Central Asia Regional Economic Cooperation (CAREC) Program

- Spanning 11 countries* from East Asia to Europe
- Conducted Midterm Review of the Transport Strategy in 2025



* CAREC = The Central Asia Regional Economic Cooperation covering Afghanistan, Azerbaijan, People's Republic of China, Georgia, Kazakhstan, Kyrgyz Republic, Mongolia, Pakistan, Tajikistan, Turkmenistan, and Uzbekistan. ADB placed its regular assistance to Afghanistan on hold effective 15 August 2021.





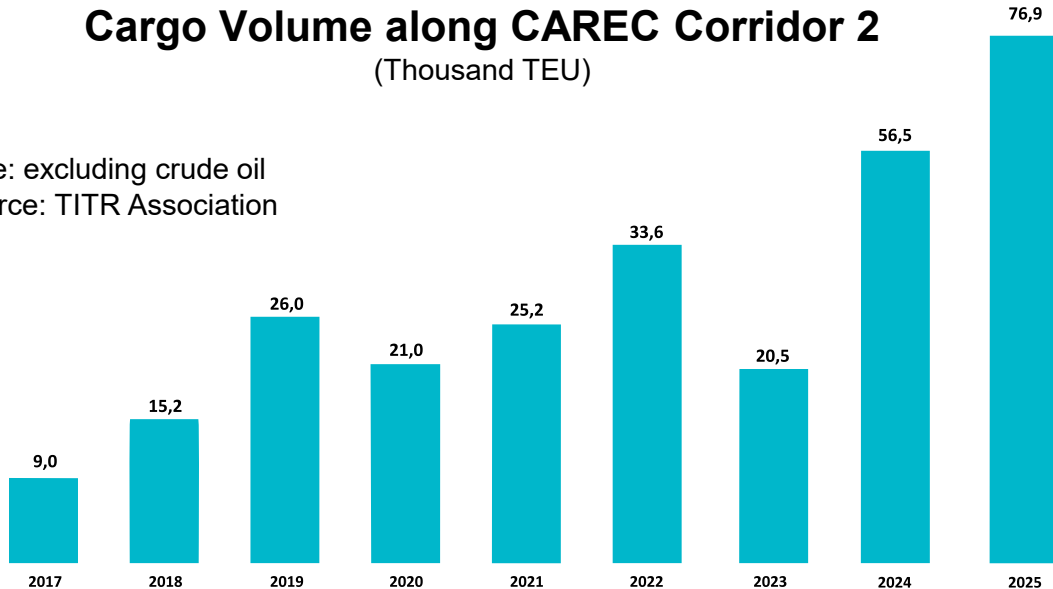
Strategic Gateway for Europe Serving as a Vital Land Bridge

Growing Demand vs Outdated Infrastructure

- CAREC trade volumes are expanding, but aging infrastructure and paper-based processes limit capacity.
- Europe's access to Central Asian markets (machinery, chemicals, and consumer goods) and to critical raw materials face unnecessary friction, raising costs for businesses.

(Thousand TEU)

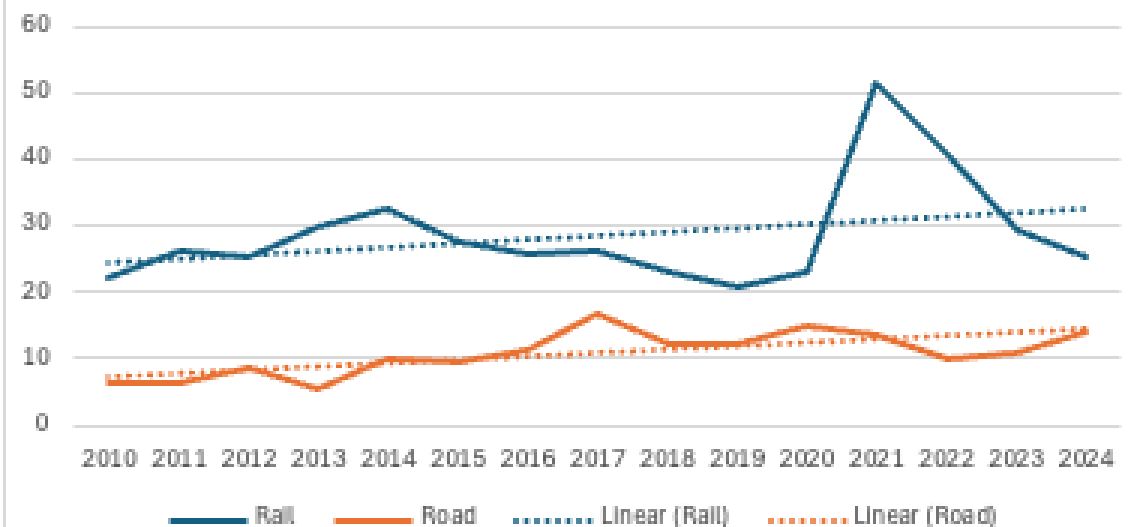

Slow and Costly Border Crossings

- Average wait times at CAREC borders range from 12 hours (road) to 26 hours (rail). Over 30% of transit time is spent at borders, disrupting just-in-time supply chains
- Cumbersome and slow border crossing procedures.
- Inefficient and duplicative customs, immigration, security, sanitary, and phytosanitary inspections.

Time taken to clear BCP (hour)





BUILD (Borders Upgrades for Integration, Logistics, and Development) Facility

- Financing facility for border crossing point (BCP) improvements in CAREC region to address infrastructure and soft-side needs and to promote joint BCPs
- Adopt a strategic and programmatic approach.
- ADB financing of \$400 million to finance a series of individual small-value BCP projects (up to \$50 million) along the CAREC network.
- Projects to be implemented over 10 years.
- Build upon ADB's extensive experience on BCP projects in the region (6 completed, 8 ongoing) showing significant cost and time reduction at BCPs.
- Yallama BCP (UZB) reduced the average customs processing time from 11.4 to 4.4 hours.
- Altanbulag and Bichigt BCPs (MON) contributed to drop of average road border-crossing cost by 40%.





BUILD Partnership

- ADB's long-term commitment of \$400 million for BCP improvements will:
 - **unlock opportunities** for European firms to participate in infrastructure and digitalization projects creating new markets for European goods and services.
 - complement Europe's **Global Gateway** strategy and advances Europe's commitment to global development and poverty reduction.
 - provide visibility for both ADB, its developing member countries (DMCs), and development partners, to program and design such projects in a structured manner.
 - provide more opportunities for private sector.
- ADB is **seeking approx. \$150 million grant and concessional co-financing**:
 - Grant resources to offset the financing charges and interest rate of ADB loans for all CAREC countries.
 - Concessional resources comparable to ADB COL or lower for Group C countries.
 - Co-financing can be linked in various forms (for an individual project, thematic, or on trust-fund basis) anytime during the facility.
 - Early engagement is recommended.
 - Disbursement of co-financing funds can be frontloaded
 - opportunities for private sector.



BUILD: Timeline

- 2025: Initial CAREC country consultations conducted.
- 16–19 June 2025: CAREC Transport Sector Committee Meeting and CAREC Senior Officials Meeting endorsed the BUILD approach.
- 20 November 2025: CAREC Ministerial Conference endorsement.
- 22 December 2025: ADB approved the BUILD Concept Note.
- **March 2026: Technical Assistance (\$1.25 million ADB financing) approval.**
- **June 2026: ADB approval of the BUILD facility**
- **2026-onwards: Individual projects designed (ongoing) and approved.**





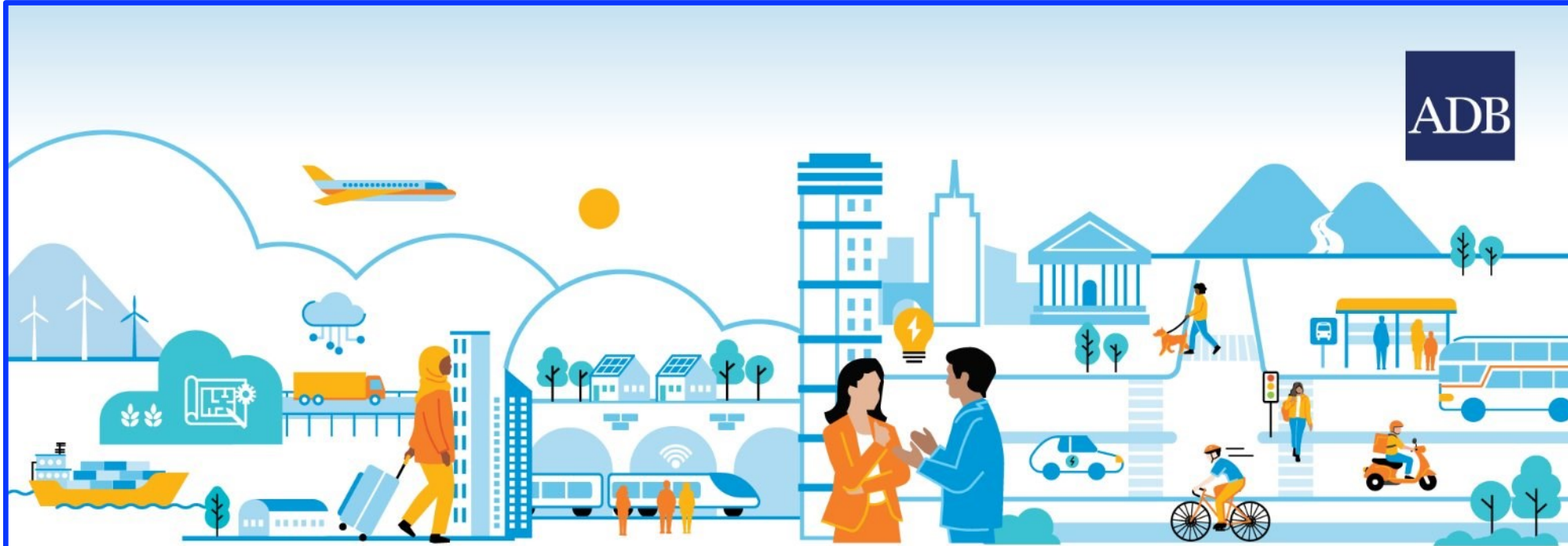
