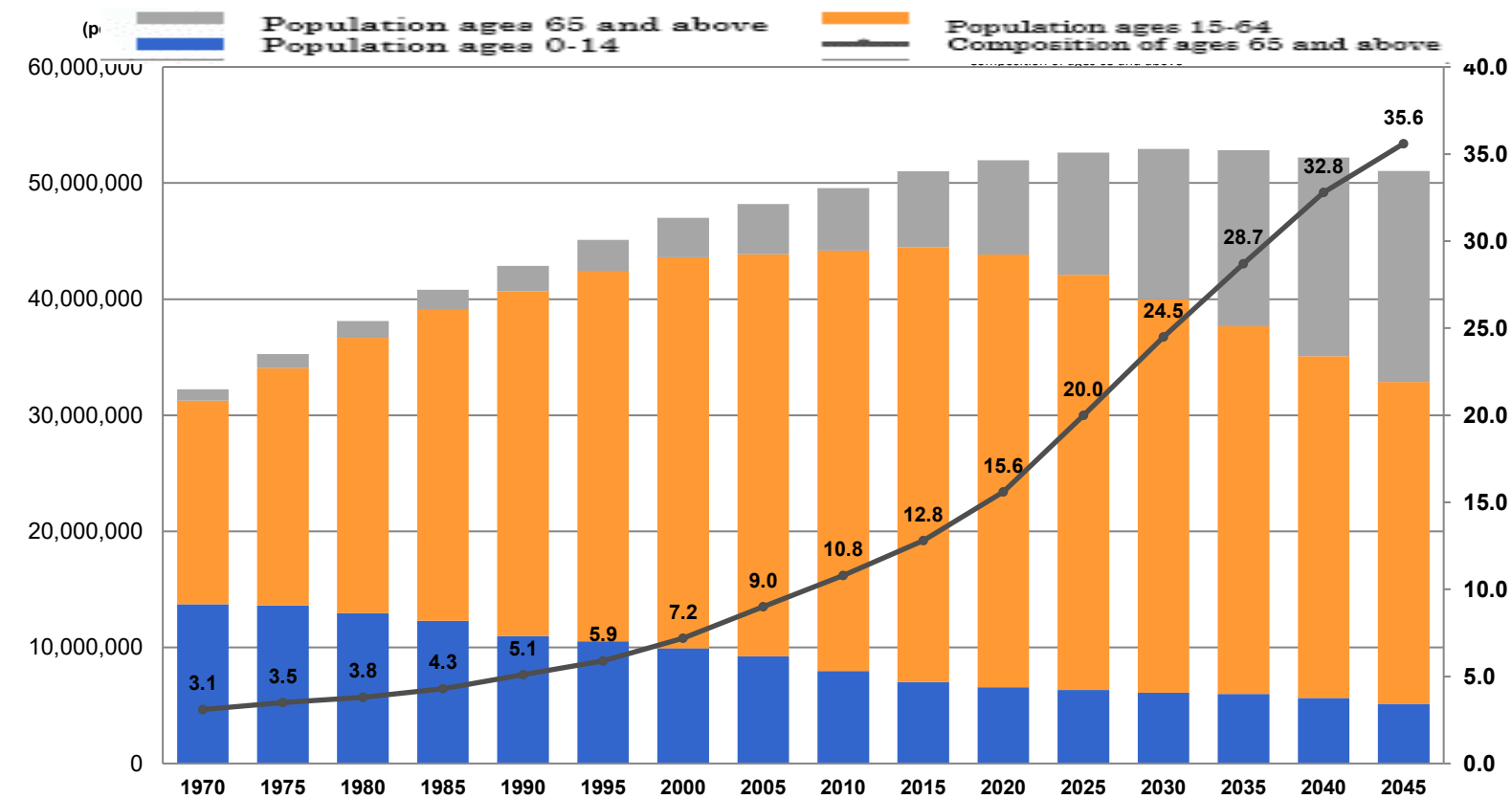

1 Implications of Rapid Aging : Increasing Diseases Burdens Due to Population Aging



- Population over 65Y was over 20% of total population in 2025
- The percentage will reach over 35% of total population in 20 years later

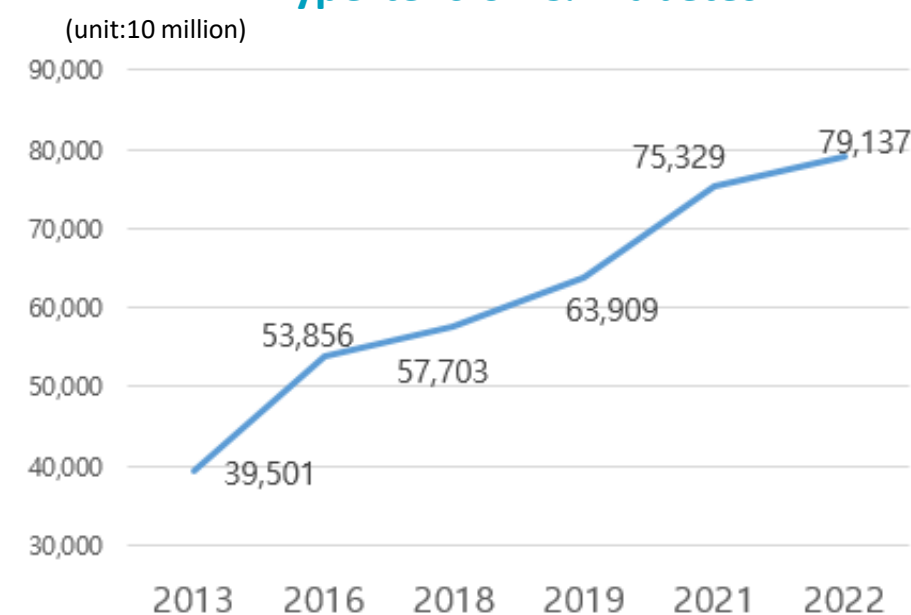

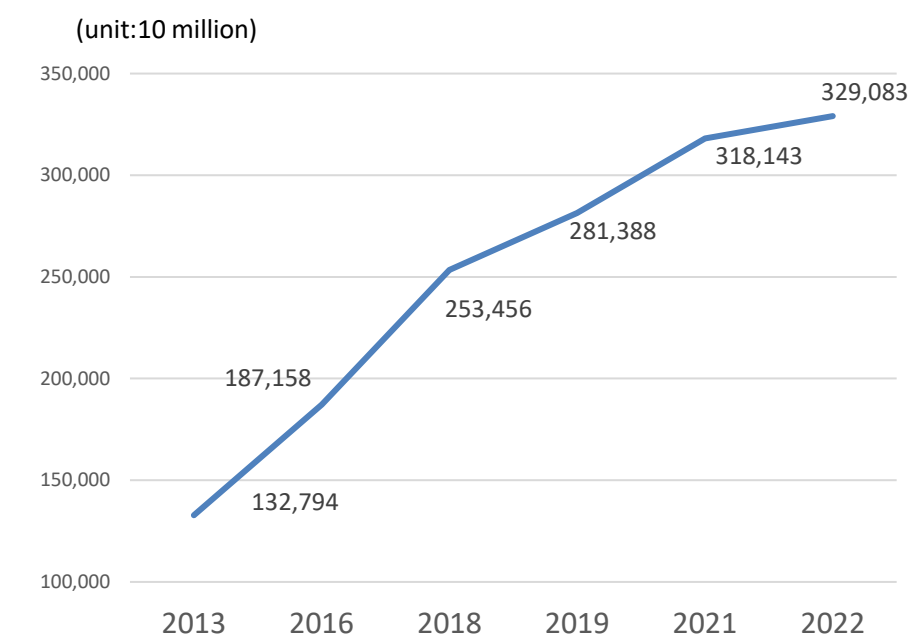


- 20.6 million patients with NCDs (40.1% of the total population)
- Treatment cost for chronic disease is almost 3 billion dollars (38% of the total treatment cost as of 2022)

Lifetime Periodic Health Screening & Cancer Screening

< Lifetime >

Infants
(4mth~71mth)

Screening for Infants

- 7 times until the children start school
- Basic medical exam, questionnaire and diagnosis
- Developmental evaluation and consultation
- Health education for parents

Youth
(6~18 yrs)

Screening for Students

- Students in primary, middle and high school
- Basic medical exam
- Pathology exam
- Dental check

Health Screening For Out-of-School Children

- Out-of-School Children (9~24 yrs)

Adults
(over 19 yrs)

General Screening
(NCDs focused)

- Basic medical exam and health questionnaire
- Breast radiography check
- Urine and blood test
- Dental check

Cancer Screening

- Stomach, liver, colorectal, breast and cervical cancer

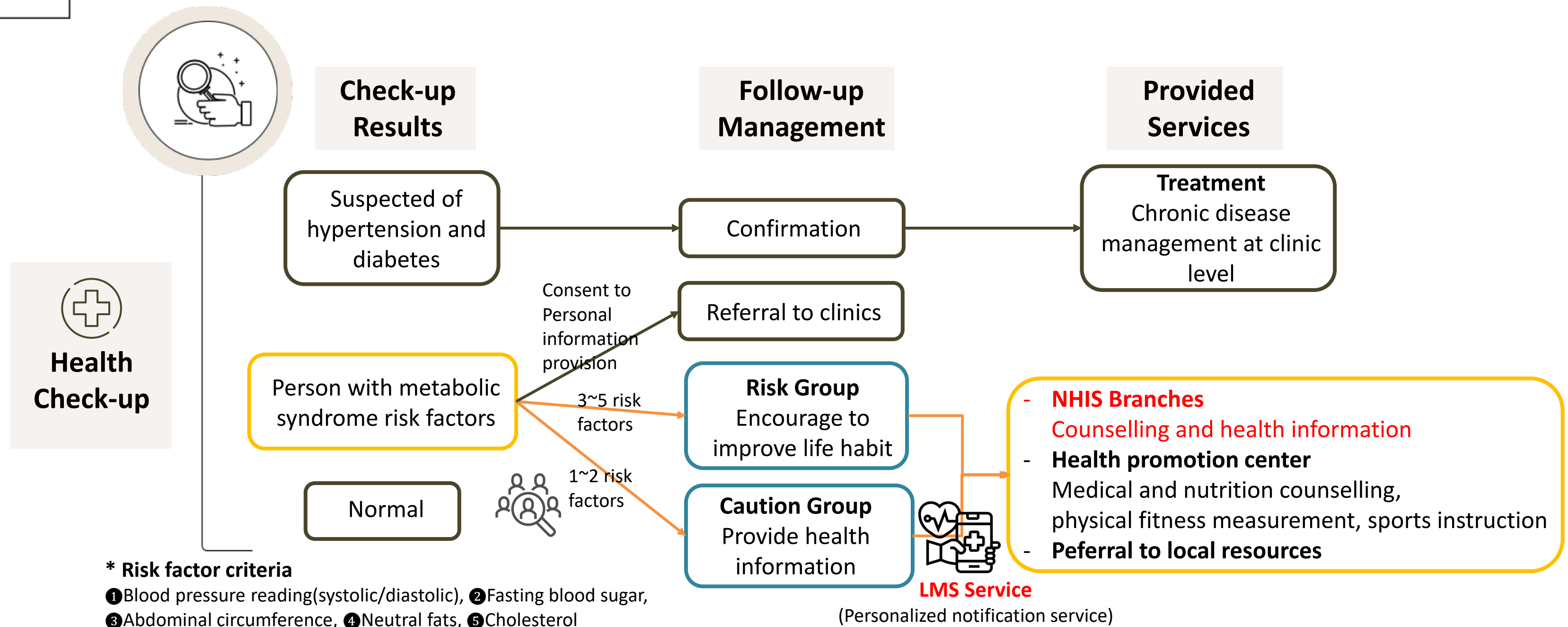
Category	Screening Age	Screening Period
Gastric	Men and Women over the age of 40	2 years
Liver	Men and Women at high risk who are over the age of 40	1 year
Colon	Men and Women over the age of 50	1 year
Breast	Women over the age of 40	2 years
Cervical	Women over the age of 20	2 years

< Cost payment >

- ▶ For regular cancer check-up : co-payment 10%
(except Cervical patients pay none)

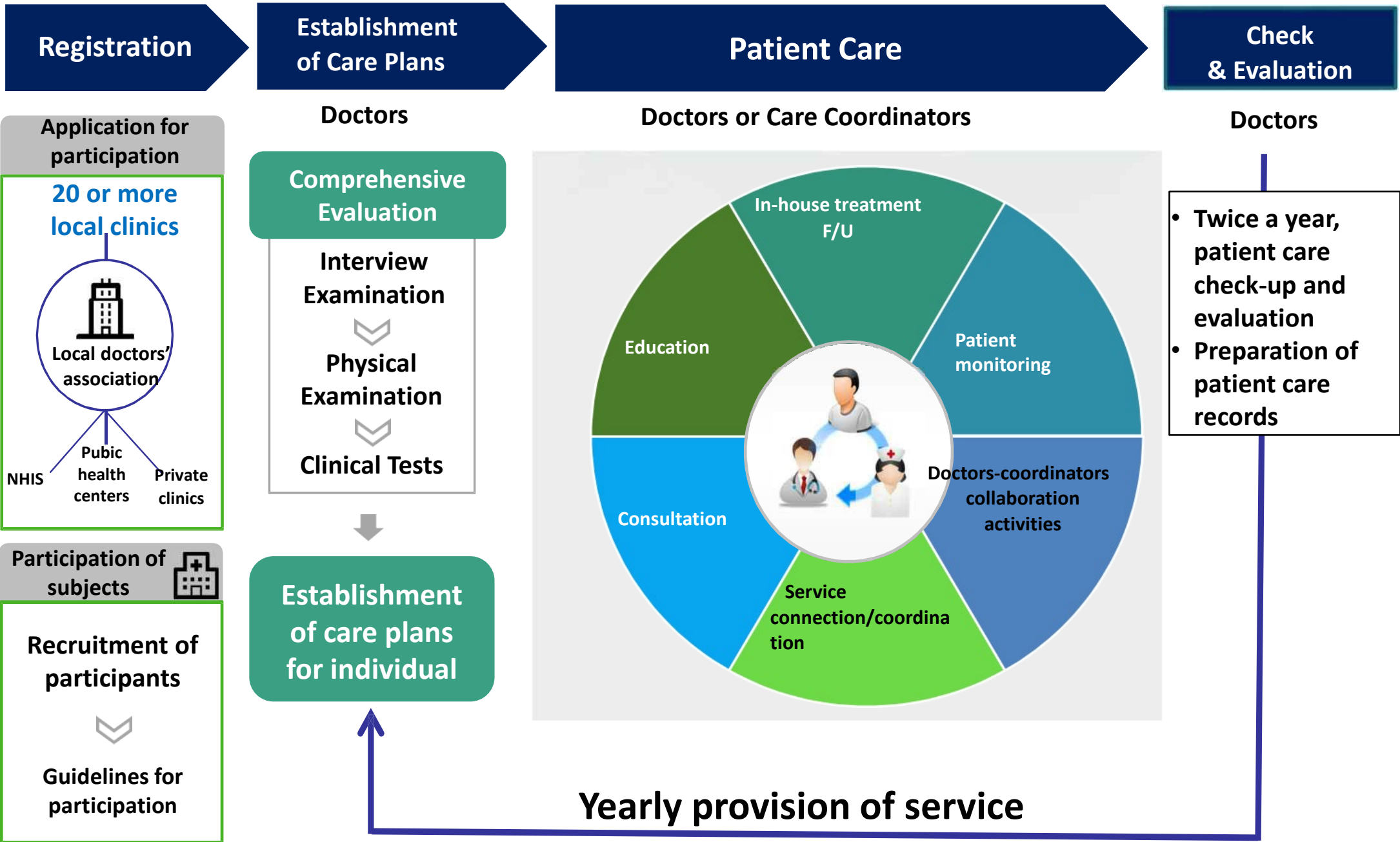

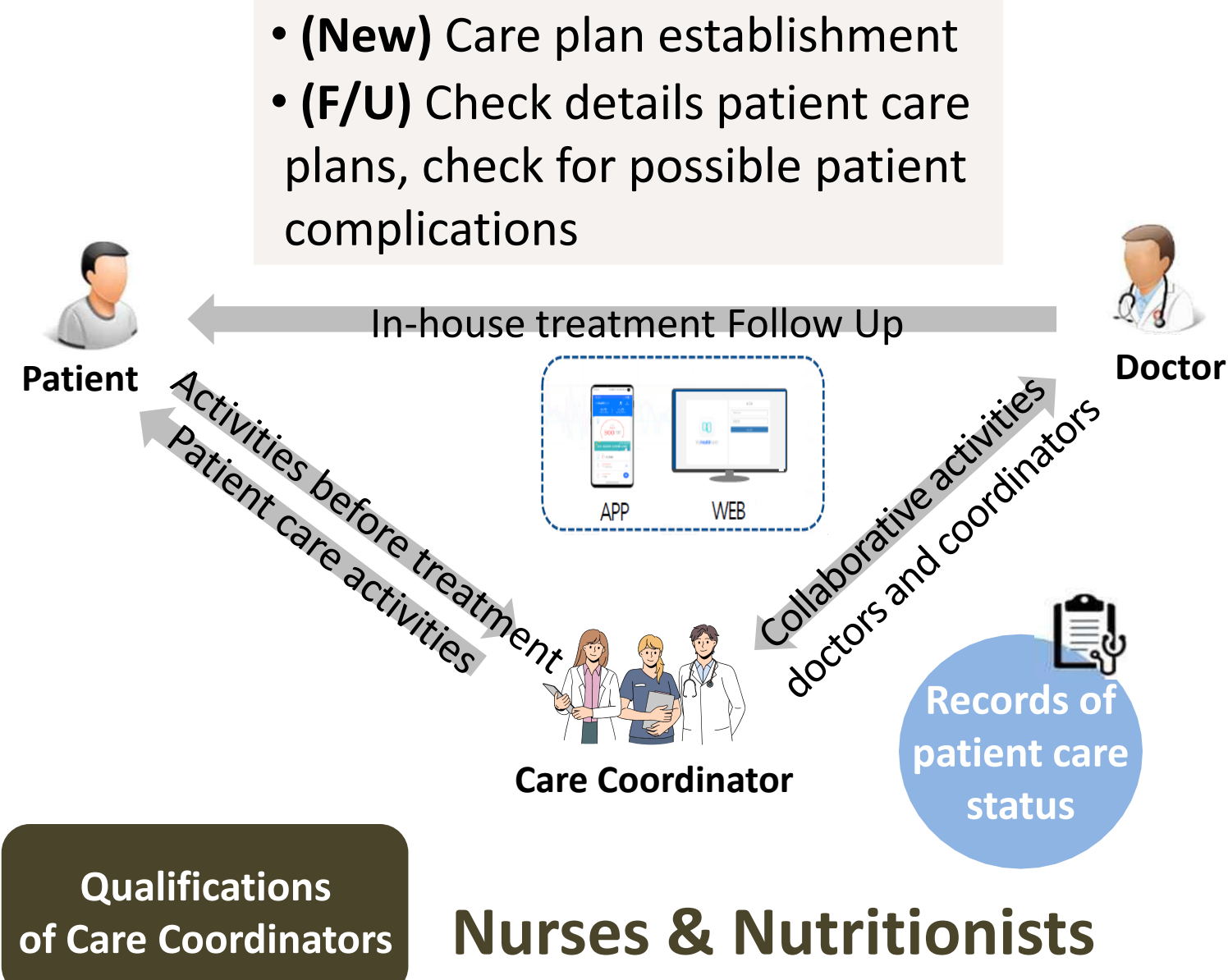
Primary Care Based NCDs Management System:

3. NCDs Management System

1 Primary Care Based NCDs Management System: Care Coordinator Model

- **(New patients)** Interview examination, physical examinations, lifestyle survey, etc.
- **(Enrolled patients)** Check records for blood pressure and blood sugar levels at home, check compliance with medicines, check degree of care plan implementations, etc.



※ Patient care activities


1. Blood sugar/pressure monitoring
2. Medicine adherence monitoring
3. Check lifestyle execution
4. Guide for visit schedule(recall)
5. Check-up for complications
6. Education
7. Consultation
8. Resource Linkage

2 Personalized NCDs Management System: Customized Self-Care Support Services



< NCDs Management Support Services >

- ① **(Objective)** Improving self-care capabilities of patients with hypertension and diabetes
- ② **(Targets)** Applicants Patients for primary care based NCDs Management Services
- ③ Providing customized self-care support services
 - Tailored health information for patients / Individual health counseling services
- ④ IT based NCDs Management Support
 - Providing LMS service: Customized health information services based on basic health behavior survey results
 - Online Health information portal(www.nhis.or.kr)
 - Home Monitoring Device Rental Services
 - Rental of blood pressure and blood glucose monitors
 - Provision of consumables (e.g., test strips, lancets)
 - Education on proper measurement techniques

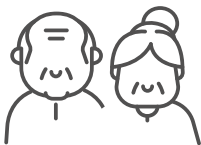

3 Polypharmacy Management: Polypharmacy Management Services



Target groups

- 1. Patients from long-term care facility
- 2. Patients with one or more NCDs, and regularly taking 10 or more medications
- 3. Patients taking high-risk medications

Selection

Participant Selection using Big Data



- > Sending information letters
- > Obtaining consent-> Proceeding with the intervention

Community Based Model

Home visits by Health Professionals(doctor, pharmacist, nurse), or Pharmacy visits by the patients

LTC Facility Model

Comprehensive medication review & adjustment through interdisciplinary collaboration by doctor-pharmacist-nurses

Participants

132 communities, 60 hospital, 3796 patients as of 2024

1. Increase of NCDs Patients due to Population Aging

- Higher prevalence and risk among the elderly
- Leads to rising social and economic burden

2. NCDs Management Systems by NHIS

- National Health Check-up and Follow up Service
- Primary Care based NCDs Management Service
- NCDs Management Support Services
- Polypharmacy Management Service

3. All NCDs related health data is integrated into NHID



4. Customized Health Management Enabled by NHIS Big Data

- NHIS big data allows for personalized health support services
- Data-driven approach enhances efficiency and targeting
